The cable will transverse under the Irish Rail Railway within the townland of Highrath and the M9 motorway in the townland of Roughfield through trenchless Horizontal Directional Drilling (HDD) methods. The underground cable is intended to connect the permitted 38kV substation in Clashwilliam Solar Farm, in Smithstown townland, with the Kilkenny 110kV ESB substation, in Scart townland. The solar farm and 38kV substation were granted permission by Kilkenny County Council pursuant to Planning Registration Reference 20897). Permission is sought for a period of 10 years.
